- There must be an abstract of (200-250) words;
- Essay limitation: Maximum 2000 word (Excluding footnotes);
- Full paper is required at the time of submission.
- As a supplementary file, please submit a one page summary document containing title, author, affiliations and abstract
- The Submission file must be in Microsoft word.(Font- Times New Roman, Size-12, Space-1.5, Alignment: Justified)
- For Footnotes, Font Times New Roman, Size-10, Single Spacing, Alignment: Justified.
- Referencing style: OSCOLA, HARVARD or any other unified format.

- No Registration or Submission will be considered after the Deadline.

- Multiple or Incomplete Submission will be disqualified.
- Results will be announced via email and participants registered number.
